Dear business partner,

As it is widely recognized, airports who fall under jurisdiction of Directive 2009/12/EC of the European Parliament and the Commission on airport charges dated 11<sup>th</sup> March 2009 (further referred to as the "Directive") are obliged to undertake regular consultations with their airport users on the airport charges.

Bratislava M. R. Stefanik Airport as the largest international airport in the Slovak Republic meets the set criteria and falls under the jurisdiction of the Directive. The Directive was implemented into the Slovak legal system by the act no. 213/2019 Coll. Act on Fees and Charges and Providing Contributions in Civil Aviation and on Amendments to Certain Acts (further referred to as the "Act").

Within §3 (1) of the Act the airport managing body of Letisko M. R. Štefánika – Airport Bratislava, a.s. (BTS) (further referred to as the "Airport Company") is obliged to undertake regular consultation meeting with its Airport Users and Association of Airport Users on:

- a) System of Airport Charges
- b) Level of Airport Charges
- c) Quality of Service Provided
- d) Plans for New Infrastructure Project prior Finalization
